Provisional Application (Applicant with a current Full competition license with current competition experience) Must be complete with copy of current license, list of races, documentation of six completed races (e.g., 'official' race results) from the previous twenty four months (no 'school' races), fully completed medical form (no more than 12 months old at the time of submittal), fee, proof of a current PCA Membership, and a fully completed, signed application form. See 2018 PCA Club Racing Rule Book / Licensing Procedures.

List Current Wheel-to-Wheel Competition License information: Sanctioning Body and License Number and provide a copy of current license: NASA, SCCA, POC, IMSA, BMWCCA or equivalent sanctioning body (no time trial), or any vintage group which is a member of the Vintage Motorsport Council. Equivalency is determined by the PCA Club Racing Committee.

Experience: List races you have driven AND attach 'official' race results from six different races in the past 24 months.

II. Rookie Application (Applicant without Existing Competition License and no prior competition experience) - Must be complete with listing of experience, fully completed medical form no more than 60 days old at the time of submittal, the Certification of Experience and Ability , fee, proof of a current PCA Membership, and a fully completed, signed application form. See 2018 PCA Club Racing Rule Book / Licensing Procedures.

Experience: The applicant must present evidence of having completed twelve or more days of race track driving training and experience at driver's education events, time trials, race schools or equivalent events within the past 24 months. Six of the required 12 or more days must be with a PCA (or equivalent) driver's education event. Dates, locations, sanctioning body, Chief Instructor, Run Group data, and instruction status (e.g., signed off by instructor after the first two sessions) data and a complete listing of track days shall be provided with the application. (Equivalency is determined by the PCA Club Racing Committee.)
